TO: Milton Township Residents

RE: 2015 Chloride Application for Dust Control

It's time again for Milton Township resident to order chloride for dust control on the roads.

The plan is that rocking of roads will occur this week – the week of May 11, and chloride application will be fairly soon after rocking is complete, depending on the schedule of the provider.

Last year the township began a new procedure for ordering chloride, and it worked very well, from our perspective. We will continue that procedure again. If you want to have chloride applied to your road, please do the following:

- 1) Pick up two stakes at the town hall to mark where you want chloride applied. The stakes are available in a barrel by the door of the town hall now.
- 2) Put one stake at the beginning and one stake at the end of the area where you want the chloride applied. Measure the distance between the stakes. That will be the length of area that you want chloride applied. If you want to order 18 foot wide chloride at an extra cost, put two stakes at each end of where you want it applied.
- 3) Fill out the enclosed/attached form. If you are ordering chloride for more than one location, please fill out a separate form for each location. Figure out your cost on the form based on the number of feet you want, and the cost per foot.
- 4) Send the form with a check for the amount indicated on the form to:

**Your order form and check must be received by the township by May 22<sup>nd</sup>, 2015.**

- 5) The exact date of chloride application is not known yet. As soon as we know, we will send an e-mail if you have provided one. The expected application date will also be posted on Milton Township's website: [www.milton-township.com](http://www.milton-township.com)
- 6) The chloride truck will dispense chloride between your stakes for the exact number of feet you ordered and paid for.

Because the cost of chloride from the county increased a little bit this year, we have to increase our cost to \$.42/foot for 12 foot wide chloride, and \$.63/foot for 18 foot wide.
